Dr. McCoy affirmed there is no indication the pay increases, included in action items A-D, would cause any future layoffs, programmatic reductions or decreases to any balance. He added we had an AB1200, multi-year projection, approved. Trustees were happy to provide an employee compensation increase, and be able to remain competitive to attract and retain the best and brightest to serve OUHSD students.

 Trustee Baker Torres asked that consideration be made to close the gap in pay from the lowest paid employee to the highest paid employee when classified negotiations begin.

Motion: Trustee Hall moved to accept the Oxnard Union High School District's 2021-2022 Annual Financial Report (Audit), as prepared by Eide Bailly, LLP. Seconded by Trustee Flores-Haro and carried with a vote of 4:0:1. Trustee Botello departed the meeting early; therefore, she didn't participate in the vote.

Natalie, Auditor, clarified the \$215,000 noted in the auditor's letter had to do with a letter prepared by the County Treasury not received by the district prior to the fiscal year closing on June 30, 2022; this is not an audit finding.

Motion: Trustee Hall moved to approve the allowable expenditures utilizing the Arts, Music, and Instructional Materials Discretionary Block Grant, as presented. Seconded by Trustee Flores-Haro and carried with a vote of 4:0:1. Trustee Botello departed the meeting early; therefore, she didn't participate in the vote.

• The budget for the Arts and Music Programs is proposed; therefore, in keeping with the current budget the allocated amount would be \$1,500,000.

- This block grant would allow funding of \$1,000,000 each year for Arts and Music with Proposition 28 to support additional staffing. Dr. McCoy added the district would only be accountable to match those dollars that are spent this fiscal year. Sites have been asked to budget over two years but to give three years' worth of needs.
- Dr. McCov estimated next years' match to be between \$750,000-\$1,000,000 but this depends on how fast purchase orders can be processed and items booked into the budget.
- Dr. McCoy clarified for Trustees and the public that should the Governor's proposed budget cut be enacted; the district would replace the \$405,000 lost with LCAP and future Proposition 28 funding. Art and Music departments would not be asked to cut their list back.
- RMHS band uniforms were not requested to be replaced by the site at this time but if they do request replacement, it would come from a different funding source.
- Covid funding can't be used directly for DSHS but the funding would assist in creating general fund savings that can be used towards the DSHS project. Dr. McCoy added that more information would come to Trustees on how the district is going to acquire the funding gap when we approach the Second Interim with information on the current year and the following year.

Student Representative to the Board Advisory vote: Aye

- This resolution was developed by the National Education Association and is being passed by school districts across the country.
- Critical Race Theory is a graduate level class and is not taught in Public schools so it's not part of this resolution.
- Trustee Sher brought the resolution forward out of respect for educators, OUHSD students and families to ensure the district stands by not only students and families but educators and staff that teach OUHSD students. She feels this resolution protects and
- Trustee Hall felt if the resolution passed, it would give the perception that OUHSD wasn't already doing the work noted in the resolution.

- Trustee Sher stated that a lot of the work done now as Board of Trustees is also done
 for future Trustees.
- Trustee Flores-Haro feels this resolution is a reminder to all of where we stand as a
 district.
- Student Trustee Lopez agreed the resolution is a reminder that she is protected and future students are as well.
- Trustee Hall opposed the resolution and stated he was concerned about item four on page two, "In partnership with educators, students, and the community, review the District's current curriculum in order to ensure it reflects a true history of this nation and the world we live in, and works to dismantle systemic racism and racial inequity in our schools." He is for teaching history to dismantle racism and racial inequity in our schools but he is concerned about directing the district's management team to have a partnership with educators, students, and the community as he felt this would impact the membership of the district curriculum committee and be directing the committee to review all curriculum as history exists in every class. He questioned if parents would now be part of the curriculum committee along with community members and students as this is where curriculum review takes place. He also stated he has a philosophical difference on using a resolution versus Board Policy (BP) because the BP is substantive and actionable. Trustee Hall also referred to the second number four on page two where it mentions "diverse workforce" which is one of OUHSD's Board Goals and the OUHSD team has already been directed to do this. In addition to his two objections, he felt that passing a resolution to say the law would be followed is unnecessary since we follow the law.

16. STAFF REPORT AND BOARD DISCUSSION

A. Fiscal Services Reclassification

The mission of the Fiscal Department is to ensure fiscal solvency to provide the best possible education experience for students and provide the best possible work environment for all district employees. Fiscal Services is proposing a realignment that would allow the district's vision and mission to provide all students the best education experience and better customer service to staff, vendors and the public.

- Dr. McCoy stated an OUHSD employee can request to have their position reviewed by Human Resources or their supervisor. This would also be discussed in consultation with OFTSE. There are also scope of work issues as the budget has continued to grow tremendously.
- If an employee feels they've worked out of their classification or their supervisor feels
 they've asked an employee to work out of classification, they can contact Karen Boyd,
 Director Human Resources, or Dr. Deborah Salgado, Assistant Superintendent, for
 assistance.
- Trustees asked to have a Board Policy or Administrative Procedure on reclassifications, if this item comes back to Trustees for action. Include what the procedure is to ask for review of a position, what the procedure is to start a review of a position, consider to have positions reviewed every five or ten years, what is the criteria to approve it or not and the procedure for appointment into a reclassified position automatically or would an interview have to take place. Dr. McCoy affirmed an administrative procedure can be done to codify this.
- Trustee Flores-Haro requested consideration be made for the position of a payroll lead.
- Ms. Thomas stated the position control has nothing to do with leading payroll. The senior accountant is the payroll lead and handles any payroll concerns, if needed.
- This report dealt with reclassification of two employee classifications and it's not a
 reorganization because there is no change to the supervision of the department. There
 is a new position that would come back to Trustees for consideration after due
 diligence has been done.
- New job descriptions would be taken to consultation with OFTSE leadership to request their input. Once OFTSE has offered their input then the job description comes to Trustees for consideration.

B. CTE Pathways

The OUHSD Board Goal 1 – Instruction states: "Every Student is College Ready, Career Prepared and receives support to meet High School graduation requirements". This includes creating learning environments that promote communication, collaboration, creativity, critical thinking, increasing the completion of A-G course requirements, career education pathways as well as improve the graduation rate with particular attention to students with disabilities and students who are traditionally underrepresented. This report provided an update of the Career Technical Education programs.

Trustee Flores-Haro congratulated Ms. Phillippe and her team for the growth they have accomplished with the CTE Programs since she graduated. Trustees thanked Ms. Phillippe for the work being done for students to get them on their career trajectory.

C. 2022 California Dashboard & Board Metrics

Parents/guardians, educators, other stakeholders and the public can use the California School Accountability Dashboard to see how local educational agencies and schools are performing within California's school accountability system. It provides a summary about overall performance on multiple measures of student success. Staff prepared an overview of the 2022 OUHSD Dashboard, including both State and Local indicators, as well as associated metrics aligned to the current Board goals.

- Trustee Sher restated that she opposes high stakes testing.
- Trustee Hall agreed with Trustee Sher as other institutions are abandoning high stakes testing such as eliminating the SAT from college admissions and the community college system. Four year systems are eliminating placement exams for Math and English.
- Oxnard Online is an online curriculum available to students, before and after school
 hours, that are equivalent to courses they would take with support of teachers that are
 credentialed in these programs. It was formerly known as Edgenuity and APEX.
- Trustee Sher commented on the disparity in demographics in regard to suspension rates and that OUHSD is paying close attention to this as it's one of the Board Goals.
