HIGHLIGHTS:

Reported the District received the CDS code for Oxnard Middle College. Dr. DeLeon is in the process of visting sites to address juniors during assemblies regarding the CAASPP and informing them how important it is to take the SBAC test.

14. STAFF REPORTS A. Career Education

Career Education in the Oxnard Union High School District includes two and three course Career Pathways that provide students preparation for High Need High Wage local career opportunities, Rigorous Coursework, and connection to Post Secondary programs in local community colleges, the California State University, and the University of California. District students are also offered Career Academies that wrap a particular Career Pathway around career themed core coursework, in a cohort model. Career Academies culminate in an annual cross curricular project, and provide preparation for High Need High Wage local career opportunities, Rigorous Coursework, and connection to Post Secondary programs in local community colleges, the California State University, and the University of California. The Staff Report – Career Education will update the Board of Trustees and public on the differences between District Career Pathways and Career Academies, the funding models, and outcome data from the class of 2017. Additionally, ongoing funding and next best steps in Career Education will be discussed, as well as recommended changes to the RCHS Career Academy lottery process.

Trustees thanked staff for implementing the 8th grade tours at district sites. Trustees addressed their concerns, inquiries and requests for future reports. Trustees asked Dr. McCoy to bring the removal of the RCHS zip code restriction and reason for the removal to a future board meeiting for their approval. Trustees thanked Ms. Chandler and Dr. McCoy for their report.

B. Graduation Requirements Update & A-G Regulations

With the sunset of the California High School Exit Exam and the addition of Trimester schedules in District Schools there are updates necessary for the District's General Graduation Requirements. Educational Services is leading a discussion of the potential revisions to the District Graduation Requirements. Tonight the Board will be updated on the current Graduation Requirements, the current UC/CSU a-g requirements, the differentiated graduation requirements for eligible Foster and McKinney/Vento youth, as well as potential changes to the Graduation Requirements.

President Davis thanked Dr. McCoy for his report. Trustees asked for clarification on the chart presented re: courses offered to students and their requirements and expressed their concerns and requests. Trustees requested that another update be brought forward before it is brought for approval. Dr. McCoy stated an update would be brought forward in April.

Consideration of Approval of the Dignity Health Grant for the Nutrition Services Farm to School Program In collaboration with Ventura YMCA and Oxnard Food Share, Nutrition Services received a grant from Dignity Health in the amount of \$15,780. The Building Healthy Families Project will provide free year-long fitness classes, nutrition education, access to fresh fruits and vegetables, opportunities for Student Nutrition Advisory Councils (SNAC) to participate in community service projects and continued focus on the school site garden development and promotion. This project will be broken into (4) 6-week sessions and (2) 8-week sessions totaling 40 weeks of programming.

B. Consideration of Approval of Renewal of the Frank McHugh-O'Donovan Foundation, Inc. Grant for the Nutrition Services Farm to School Program Nutrition Services received a renewal of the grant from the Frank McHugh-O'Donovan Foundation, Inc. in the amount of \$76,500. This was originially awarded in 2015-2016 and again in 2016-2017. The grant is specified for use within the development of the farm to school program. Bringing more locally sourced, fresh fruits and vegetables into school cafeterias is the driving force behind our OUHSD Farm to School program. These grant funds will continue to support the commitment to local procurement with farmers and local companies. In addition to procurement activities, the grant funds will also support food, agriculture and nutrition-based educational efforts consisting of hands-on experiential activities, such as school gardens, field trips to local farms, and cooking classes.

Concern from Trustees about OUHSD funds being used and if staff will be hired to fill the positions listed. Mr. Albaugh replied that independent contractors will be hired for the positions listed through a RFQP process. Trustee Herrera confirmed that no district funds will be utilized, strictly from the grant, and these positions will sunset in April 2020. Ms. Gillenberg affirmed this. Trustees expressed their concerns about food being consumed by students from the gardens. Ms. Gillenberg informed Trustees that she will attend training through USDA on how to handle the food grown and consumed by students.

Motion: Trustee Hall moved to approve the California Department of Food and Agriculture 2017 Specialty Block Grant for the Nutrition Services Farm to School Program, as presented. Seconded by Trustee Sher and carried unanimously. Vote 5/0 Board Policy 3553 requires Nutrition Services to follow all federal regulations related to serving "one nutritionally adequate meal" and making this accessible to all students daily. The policy also ensures that free and reduced meals follow all federal nutritional standards and that students eligible to receive free and reduced price meals are not overly identified.

E. Consideration of Approval of Proposal to Perform a Preliminary Environmental Assessment (PEA) for the Proposed Oxnard Area Growth High School No. 8 Site

For districts seeking State Facility Program funding or CDE approval a Preliminary Environmental Assessment (PEA) is required when the Phase I ESA identifies environmental concerns. Tetra Tech has extensive experience in working with the Division of Toxic Substances Control (DTSC) and will prepare a report on RECs 1-5 in accordance with the guidelines and formats prescribed in the PEA Guidance Manual. A separate report will need to be conducted on the water pipeline (REC #6).

Consideration of Approval to Solicit Qualifications and Proposals for Financial Advisory Services-General Obligation Bonds Motion: Trustee Sher moved to approve the proposal to *Perform a Preliminary Environmental* Assessment (PEA) for the Proposed Oxnard Area Growth High School No. 8 Site. Seconded by Trustee Hall and carried unanimously. Vote 5/0 The District is in the process of creating a long-term facilities master plan that will prioritize facility improvements and identify the funding sources available for updating facilities and for new construction projects. Although the State of California provides one source of funding through modernization and new construction grants to schools, most districts rely on local funding sources, including general obligation bonds, to improve and construct facilities. Pursuant to the Board's action to seek approval of \$350 million in local general obligation bonds, District Administration believes it is in the best interest of the District to obtain and review the qualifications, success history and cost of experienced financial advisory firms who provide these services.

On or about February 1 of each year, the Superintendent or designee shall annually publicize the issuance of the SARCs, publish the SARCs on the District Website, and notify parents/guardians that a paper copy will be provided upon request.

Consideration of Approval of Revisions to *Board Policy 4119.23;* 4219.23; 4319.23: Unauthorized Release of Confidential/Privileged Information [Second Reading] Government Code 54963 specifies that a person may not disclose confidential information acquired during his/her presence in closed session. An employee who willfully discloses confidential information may be subject to disciplinary action provided that the employee has received training about this law or otherwise been given notice of its requirements. However, the district may not take disciplinary action against an employee for releasing information if the disclosure was part of an investigation by a grand jury or the district attorney's office, part of a whistleblower action, or merely an opinion as the legality of a Board action. There are no Administrative Regulations for this policy. Disciplinary actions for employees who are in violation of this policy will be in accordance with Education Code Section 44932 (attached). Language for this board policy was obtained from GAMUT, an online service provided by the California School Boards Association (CSBA).

WHEREAS, Oxnard Union High School District already administers the SAT annually to all students in grade 11; and


