9. SUPERINTENDENT'S REPORT

Dr. DeLeon informed Trustees that Dr. Pedro Noguera will be this year's guest speaker at the District kick-off on August 23, 7:30 a.m. at Pacifica High School. Dr. DeLeon reported on the Chromebook Initiative to be implemented beginning the week of August 19 at Hueneme, Frontier, Channel Islands and Condor High Schools. All students will receive a Chromebook to take home and students who do not have access to WiFi will also receive a hotspot. In addition, students will be afforded the opportunity to purchase their Chromebook for \$ 5.00 after graduation. Oxnard and Pacifica High School students will receive this benefit next school year.

10. DISCUSSION ITEMS

A. Consideration of 2019-20 District/Board Goals

Trustee Davis read and opened for discussion the 2019-20 District/Board Goals.

Trustee Sher recommended to incorporate "equity and access" in the Vision statement.

Goal 1: Trustees Edmonds, Sher and Herrera had no revision recommendations. Trustee Davis recommended removal of the second sentence and subsets, Superintendent DeLeon stressed the necessisty of the subsets. Trustee Hall opined that Goal 1 drives the District's vision; "Equity and Access" should be a separate goal. Subset 1: Trustees Sher, Hall, Herrera, Edmonds and Superintendent DeLeon had no revision recommendations. Trustee Davis recommended the removal of language after "career readiness". Subset 2: Trustee Davis opined the importance of this subset; should be a stand alone or kept as a subset. Superintendent DeLeon is agreeable to changing this subset as a stand alone. Trustee Hall recommended the removal of the word "over time". Trustee Herrera would like "effective" embedded in the goal. Subset 3: Trustee Herrera would like clarification on "subgroups". Superintendent DeLeon recommended to reorganize the subsets under Goal 1. Goal 2: Superintendent DeLeon recommended the implementation of MTSS and the addition of "wellness". Trustee Sher opined that "wellness" should be a stand alone. Trustee Herrera recommended to revist and ask for clarification on "wellness". Trustee Hall recommended to evaluate intervention measures, Goal 3: Trustee Davis recommended "mathematics" remain in this Goal. Goal 4: Keep - no changes. Goal 5: Trustee Hall inquired about boundary changes timeline. Superintendent DeLeon informed Trustees boundary changes will occur after Census 2020. Goal 6: Trustee Davis recommended the removal of language after "conditions for all students". Trustee Hall recommended no revisions. Superintendent DeLeon recommended the removal of all dates. Goal 7: Superintendent DeLeon would like to focus more on the 1:1, Goal 8: All trustees recommended no revisions. Recommended additions to the Board Goals: Trustee Herrera recommended regular community updates on Measure A. Trustee Davis made an inquiry on ADA rate.

B. Preliminary Discussion of Possible 2020 Board Meeting Dates

The following recommendations were made:

- Delete January 29 and Apil 8 meetings.
- · Schedule two meetings in March, May, June and August
- Schedule one meeting in September and October
- Board Retreat August 12

Trustee Herrera announced that she has a conflict on May 27.

C. Governance Team Protocols and Procedures

Superintendent DeLeon: Goal to increase communication. Trustee Davis requested regular weekly updates and departments to be more strategic on topics/write-ups. Trustee Herrera appreciates weekly personnel updates and requested regular separate site-specific updates on Measure A to be posted on school websites. Trustee Sher requested that Measure A Updates be more accessible on school websites. Trustee Herrera would like to explore the possibility of going digital with board books. Trustees Herrera and Sher will pilot e-board books. Trustee Herrera also requested a districtwide reception held annually to allow Trustees the opportunity to meet and connect with staff.

D. Review of BP 7511: Naming New Schools – for discussion only

Superintendent DeLeon reported Ground Breaking ceremony is tentatively scheduled for October 16 and is seeking input on revisions to BP 7511 by ground breaking ceremony. A discussion ensued led by Superintendent DeLeon, informing Trustees that the school should be named after a historical figure. She further stated since the school is going to be built on a farm, it should be named after someone who has made a significant contribution to the United Farmer Workers Union like Cesar Chavez or Dolores Huerta. Additional comments were made below:

- No OUHSD individuals (current, retired employees or Board Members) should be named after schools, buildings, etc.
- Schools should be named after someone who has made a significant contribution to the community.
- · Follow CSBA guidelines.
- Form a Community Advisory Committee.
- Conduct a townhall meeting, followed by a public hearing, then adoption of recommendation.
- Trustee Edmonds is agreeable to schools and buildings not being named after individuals.
- · Trustee Hall made no revision recommendations.
- Trustee Herrera asked for clarification on the definition of "historical landmark" and "geographical location" (street, state, building, etc).

- Trustee Sher is not in favor of naming school properties after employees of the district.
 She recommends allowing the community to name the high school after a historical figure.
- Trustee Davis recommended that Administration should not make any suggestions for the naming of the school. The make-up of the Community Committee should not include any district administration/employees. The chair of the committee will present three name recommendations at a Board meeting. Trustee Davis requested revisions to the this Board Policy brought back at the next meeting with Administrative Regulations to include:
 - Definition of "historical landmark" and/or "geographical location";
 - The make-up of the Citizens' Advisory Committee;
 - Duties of the Committee;
 - · Language to include no OUHSD employees as members of Committee
 - Community Advisory Committee Chair to present three recommendations to Board of Trustees.

11. BOARD REPORT AND COMMUNICATIONS

Trustee Davis would like information on opening ceremonies for Board coverage.

Trustee Sher voiced her concern related to female students changing in their vehicles after school. Student should not be allowed to change in their vehicles – liability for the district. She would like to afford students a place to change in close proximity to their after school activities (classroom, connex containers, restrooms, etc.).

Trustee Hall reiterated concerns Trustee Sher made.

12. CLOSED SESSION

President Davis announced that Trustees would return to Closed Session at 6:40 p.m.

RECONVENE IN PUBLIC REPORT ON CLOSED SESSION ACTION The Board of Trustees returned to Open Session at 7:40 p.m. President Davis reported that Trustees approved a 1.5 percent off schedule increase, given to all employees, to the Superintendent's contract.

13. ADJOURNMENT

President Davis adjourned Open Session at 7:45 p.m.
