President Davis stated he supports the procedures for providing the labor agreement, but his concern is not the need of a workforce coordinator but the fact that he was informed at a previous meeting that there would be no cost for this position but now it sounds contrary. Mr. Weinstein replied that there might be some confusion with the two separate positions, Labor Compliance; dealing with fair wage payments and monitoring of the number of people being utilized at a job site, and PLA Compliance; dealing with the local hire and the ability to allow for OUHSD graduate internship programs. Parsons Constructors, Inc. (the vendor) deals directly with labor compliance as far as payment wages and monitoring of items that are government regulations. Mr. Weinstein added that responsibilities with the PLA will be done internally but the vendor will be an outside third party entity that will handle the reports for the State as well as monitor all documentation. Trustee Herrera asked if this vendor will keep the District compliant with the State and if this is legally mandated. Mr. Weinstein affirmed the compliance with the State and that Districts can hire internally but due to lack of expertise internally, outside vendors are usually hired. Trustee Hall asked if the District has similar compliance issues with non-PLA projects. Mr. Weinstein affirmed this. It was also noted the vendor will track the number of local workers and submit reports to the District which will be shared with Trustees.

Mr. Weinstein replied that with the number of construction and maintenance projects taking place at this time this approval will expedite the projects. He noted that any amount above \$60,000 requires three formal bids and anything under can be negotiated through a single vendor. Trustees were informed that this approval would allow for labor and materials, not for the hiring of consultants. Trustees confirmed that any payouts would show up on the purchase orders and direct pays. Mr. Weinstein affirmed this. Trustees recommended the Superintendent be designated an additional approver for items between \$10,000 and \$60,000. Trustee Hall asked Mr. Weinstein to provide Trustees with a list of past projects between \$10,000 and \$60,000. Trustees decided to table this item for the September 11, 2019 meeting with revisions; therefore, no action was taken at this time. Trustees requested that Mr. Weinstein underscore, on the cover memo, that this allowance is not to be used for consultants, employees and state that it will sunset after the construction projects have been completed.

13. STAFF REPORT

Coastal Schools Employee Benefits Organization (CSEBO)

This presentation was an overview of the benefit plans and coverages offered to OUHSD employees for the 2019/20 school year. Employees can change or adjust their plans during the month of September, the open enrollment period for employees. The OUHSD Business Services Department works closely with our benefit provider JPA CSEBO as well as our Union partners to offer our employees the highest quality menu health care plans possible.

Trustees were informed that OFTSE representatives will visit school sites to remind District employees of the open enrollment during the month of September as will email reminders go out to employees. Trustees were also informed that Retirees with lifetime benefits, who are not Medicare age, are entitled to the same benefits as active employees.

Trustee Davis called for a break at 6:52 p.m. The meeting reconvened at 7:01 p.m.

Dr. Davis inquired about the Special Education encroachment. Mr. Weinstein replied that the \$3.8 million encroachment covers Special Education needs that are outsourced but the total encroachment is \$7 million. President Davis asked if there have been any contributions made for OHS#8. Mr. Weinstein replied that there is a tentative \$200,000 but there is a plan at 1st Interim to recommend a larger amount, pending enrollment. Trustees were informed that the Title 1 and Migrant fund carryovers were anomalies. Trustees had a brief discussion about the summer school incoming fund carryover and when it would be used. It was suggested that it could possibly be used for future summer school expenses.

Mr. Weinstein recognized OAS for being self-funded and having a surplus of almost \$200,000 due to the incredible job of Principal, Kathy Greaves. Stephanie Gillenberg, Director Food Services and her team, were also recognized for having perfect audits in both State meal and financial plans. Mr. Weinstein stated that 2.4 million meals were served during the 2018-2019 school year, not including adult or staff and charter partner school meals. This is a 17% increase over past years.

Motion: Moved by Trustee Sher to adopt Board Policy 3516.5: Emergency Schedules [Second Reading], with amendments: strike the word "consecutive" in paragraph two, add: "see attached MOU for criteria for closing for excessive heat" and "this policy will be revisited every two years", at the bottom. Seconded by Trustee Hall and carried unanimously. Vote 5/0. President Davis requested that the MOU be updated as well.

Trustees Hall and Edmonds were opposed to naming a school after an individual. Trustee Davis was not opposed to naming a school after an individual. After a brief discussion Trustees decided to vote on excluding the naming of a school after an individual. Trustee Herrera stated there might be a controversial situation due to the diverse community surrounding Oxnard HS#8. Trustee Herrera encouraged Trustees to not engage in this process as they may have trouble considering what has more merit or what is more valuable when considering the naming of a school. Trustee Herrera feels that communities such as the African American, Latino, Filipino and Asian American could possibly be torn apart based solely on the name of a school. Trustee Herrera's concern is that Trustees will make the final decision on the name of a school instead of focusing on educating students. Trustee Herrera asked if National Parks are considered a geographic location and if a name such as Anacapa HS, East Village HS or Camino del Sol HS could be considered. Trustees felt it was acceptable to name a school after a National Park but not after a National Landmark or street name that contains a person's name. It was recommended to have the committee present a minimum of three and a maximum of five names to Trustees for Oxnard HS #8. Trustees recommended moving the Oxnard HS#8 groundbreaking to November, not October as previously recommended.

Motion: Trustee Hall moved to exclude the naming of a school after an individual. Seconded by Trustee Edmonds. Roll call vote: Trustees Herrera, Hall, Edmonds and Sher voted yes; Dr. Davis voted no. Vote 4/1

Motion: Trustee Hall moved to reaffirm Board Policy 7511: *Naming New Schools*. Seconded by Trustee Edmonds and carried unanimously. Vote 5/0

Motion: Moved by Trustee Sher to approve the OUHSD Vision and Goals for 2019-20, as presented. Seconded by Trustee and carried unanimously. Vote 5/0

President Davis recommended that the following be a stand-alone goal: Provide access to mental health supports to promote the social-emotional wellness of every student Trustees agreed to remove the goal regarding fiscal solvency, but it will become a Board Policy.
