11. DISCUSSION ITEMS

1. Review of 2021-2022 Board Goals

- Trustees requested to have the mission and vision statement updated. Dr. McCoy affirmed that Trustees can take action on it at the next Board meeting.
- AP exams taken by students have increased since the cost of the exams is covered by the District. Exam costs would be an ongoing practice as it's budgeted in the LCAP.
- The free AP exams practice is publicized through AP Teachers, site video programs and other news and information. Sites will also make an effort to get this information out to all of their parents.
- Dr. McCoy stated there was a significant decline in AP enrollment coming out of COVID.
- OUHSD encourages students to take both the AP class and AP test and to also take a class through dual enrollment for earning college credit while in high school.
- Dr. McCoy informed Trustees that all district Wellness Centers are fully staffed.
- Dr. McCoy stated OUHSD is trying to be more finely tuned with making sure every site
 has access to our community based organizations and other providers. Trustees may see
 a proposal around developing some internal social workers to help coordinate cases
 internally that would help manage cases externally. Dr. Rossi and Mr. Adams are
 working on initial grant funding opportunities to provide this at no cost to the district.

2. Updates to 2022-2023 Board Goals

Board Goal 1 revisions from Trustees:

- Improve the graduation rate but also add a bullet point to reflect the improvement of the graduation rate for special populations.
- Add language to address dual enrollment in regard to helping students achieve college credits.

Board Goal 2 revisions from Trustees:

- Develop pathways specifically to CSU and UC schools that offer mental health professional programs.
- Add language "outreach to ensure that students are invited and feel welcomed to after school activities."
- Add a bullet regarding "goal to destigmatize seeking help for mental health issues."
- Add language about the implementation of an emotional support animal program.
- Add language to address specific needs of the Wellness Specialists for the centers.
- Add language regarding 2023-2024 incoming freshmen support needs.
- Bilingual staffing and culturally responsive staff for the Wellness Centers.
- Add language to address Special Education students to the bottom of the second bullet point.
- Language regarding Teachers or staff already supported at the sites.
- Language regarding family outreach such as phone calls or finding outside therapists due to lack of referral to Kaiser.
- Add language to the first bullet point regarding comprehensive wrap around services
 that states OUHSD actively partnering with our local agencies and nonprofits to make
 sure we actually do reach out to local therapists due to the influx of students.
- Address special needs of male students regarding therapy needs and services.
- Add the six pillars of community schools language.

Board Goal 3 revisions from Trustees:

- Add language to have a regular ongoing budget, above the 3%, for transportation, technology refresh and routine restricted maintenance.
- Language to address that the district's goal is to make sure that every student is treated
 with kindness and respect both in the classroom and with regard to any intervention
 services.
- Add language regarding OUHSD being environmentally conscious.

There were no revisions requested for Board Goal 4

Board Goal 5 revisions from Trustees:

Trustees decided to keep this goal and asked Dr. McCoy to expand on it; development, implementation and what the next growth steps are.

Trustees thanked Dr. McCoy and his staff for helping students and Trustees succeed.

13. STAFF REPORTS

A.DSHS Update

Staff shared the ongoing updates of DSHS scheduled to open fall 2023. Updates shall include but are not limited to facilities, construction updates, staffing, and educational programs. Discussions and planning meetings with all stakeholders are ongoing.

- Trustees were informed of the district's project labor agreement (PLA). Local labor participation is 66% at DSHS and 64% overall in the district.
- Staff has to apply for the positions at DSHS; it's not a clear transfer. Dr. Salgado stated there is an agreement with OFTSE that if more than one person applies for a position, then an interview would take place.
- Trustees requested to add "mental health" to the proposed health/medical pathway and "MC3 program" to the engineering/manufacturing/construction pathway.

Trustees thanked Dr. McCoy and his staff for the attendance boundaries community meetings that are planned to take place at some feeder district schools, in addition to an adult school office for teacher and parent meetings. Information for these meetings would be given with plenty of notice for the community.

President Hall called for a break at 8:26pm and the meeting resumed at 8:33pm

B. Budget Update

Mr. Lawrence gave updates on the 2022-2023 adopted budget.

- The Learning Recovery Emergency Block Grant is a one-time funding source and there are restrictions. Staff will check the guidelines to see if it can be used for facilities.
- Trustee Sher asked Mr. Lawrence to inform Trustees of the Special Ed funding increase amount via the Friday Update. Mr. Adams added that he is working with VCOE to ensure the guidelines for this funding are followed.
- Mr. Lawrence affirmed that some of this funding can be used to grow after school activities and improvements for nutrition services.

 Mr. Adams added that he would like to make sure that all of the services that are being provided to students are increased utilizing this funding.
