# AUDIENCE TO ADDRESS THE BOARD OF TRUSTEES

#### ACTION ITEM

Presented Stocks asked Trustees to voice their concerns regarding the agreement for interim superintendent.

CONSIDERATON OF INTERIM SUPERINTENDENT AGREEMENT

Trustee López Hanson inquired why the meeting was being held, she thought the Board had resolved everything at the last meeting, she stated that at the last meeting she had cast the lone dissenting vote. She stated the district is in difficult economic times, we are looking to shorten the school year, to decrease salaries and had a problem with the amount stated in the interim superintendent's agreement. She is fully aware that the agreement does not include benefits, but she has a problem with the amount of \$10,000.00 for relocation costs. She reiterated the selection process was handled unprofessionally, the Board was pressed for time from the get-go, she received no information on Dr. Carter, and closed by stating she was not comfortable with the selection.

Trustee Jáquez stated it was his decision to base the salary of the interim superintendent on the report presented by the Grand Jury, he selected a salary that was equal to that of the current superintendent, and he expressed dissatisfaction that the District's attorney was not present at the meeting.

President Stocks stated he was satisfied with the salary for the interim superintendent.

At the request of Trustee López Hanson, Mr. Schwartz, from the District Attorney's office, discussed the proper procedures for approving the contract for the interim superintendent. He quoted Government and Education codes delineating the appointment of a public employee, and the discussion of salary and vote in open session. Mr. Schwartz stated by following these procedures the Board would cure the error made at the previous meeting.

#### **ACTION ITEM - Continued**

Trustee Valles reiterated the salary was based on the Grand Jury Report and felt this offer was a fair offer. He commented the Oxnard Union High School District Superintendent's salary was the lowest salary in the County.

At the request of President Stocks, Mrs. Serros stated The Interim Superintendent's annual salary under this agreement shall be two hundred and ten thousand dollars (\$210,000). The Board will provide a one-time relocation allowance of up to ten thousand dollars (\$10,000), following receipt of itemized statements for such expenses.

On motion of Trustee Valles, seconded by Trustee Jáquez and carried 3:1; the Interim Superintendent Agreement was approved. A Roll Call vote was taken. Ayes: Trustees Jáquez, Valles, and Stocks. Noes: Trustee López Hanson. Abstained: Trustee Benefield.

**ADJOURNMENT:** It was moved by Trustee Valles, seconded by Trustee Benefield that the meeting be adjourned at 12:47 p.m.
